



# LEVEL 2 AND 3 SUITE OF FORESTRY AND ARBORICULTURE CERTIFICATE OF COMPETENCE QUALIFICATIONS

## LEARNER GUIDE

### What is it?

These are a range of practical assessments covering all aspects of Chainsaw work. Level 2 maintenance of the chainsaw and cutting system and cross cutting timber are the mandatory qualifications that are a pre-requisite to many of the Level 2 and 3 qualifications. Once the mandatory qualifications have been achieved, learners can take further City & Guilds qualifications to meet the needs of their chosen career pathway.

### Why do it?

City & Guilds NPTC Chainsaw qualifications show that the operator has practical experience, technical knowledge and their ability has been rigorously assessed. Achieving qualifications identifies a competent operator and helps to meet the health and safety requirements of the industry.

## How is it assessed?

It is a practical assessment. The learner will be observed completing a series of tasks relevant to the qualification and the assessor will ask questions to check understanding. Integrated Assessment means that the assessment will be part of the training package. Independent Assessment means the learner will take the test on a separate occasion with an Independent Assessor who has not been involved with the training. At the end of both types of assessment the learner will be advised of their result.

## Is training required?

- If you choose Independent Assessment you may have had “on the job” training, or you may wish to take a training course. Training can be provided through training providers and colleges.
- Integrated Assessment automatically involves a training course. This is designed to provide the knowledge, skills and resources required for the qualification. Integrated Assessment is offered when a qualification requires mandatory pre-requisites or is considered a lower risk.
